A Tale of Decline, Excepting Medicaid

Federal Funds Information for States (FFIS), publisher of *Reports*, recently released an analysis of federal grants that compares each state's receipt of fiscal year 2015 funding on a per capita basis. The national average was \$1,827, an increase of \$170 from the previous year.

Climbing Medicaid Clawbacks
