## Summary

*The VIP Series* focuses on federal grant-in-aid programs in the FFIS database that are of most importance to states. While FFIS tracks more than 240 grant-in-aid programs, the lion's share of federal aid, almost 70% of total funding tracked by FFIS, is reported here.

This edition of *The VIP Series* estimates the impact of the president's proposed budget for fiscal year (FY) 2016.

It also includes estimates for FYs 2015 and 2014, as follows:

FY 2015 figures are based on the omnibus budget (P.L. 113-235), which Congress passed in December 2014. It includes all appropriations bills except the one for the Department of Homeland Security. That department is covered by a continuing resolution (CR) that expires February 27, 2015. The FFIS estimates for grants in that department are based on H.R. 240, an appropriations bill that has passed the House and is currently under debate in the Senate. In addition, FY 2015 figures reflect the impact of the Budget Control Act (BCA; P.L. 112-25) on nonexempt mandatory programs (-7.3% cut).

FY 2014 figures reflect final appropriations as a result of the Consolidated Appropriations Act of 2014 (P.L. 113-76) and the impact of the BCA on nonexempt mandatory programs (-7.2% cut).

As it does every year after the budget is introduced, FFIS will update all the programs in its grants database to reflect the impact of the FY 2016 budget proposal. That update will be released to database subscribers and available at [www.ffis.org](http://www.ffis.org).
